

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that LABRADEX CORPORATION, by its agent, the undersigned, a citizen of the United States, on the 14 day of May, 1981 located the G-14 Lode Mining Claim in accordance with the 1872 Mining Laws of the United States and all subsequent acts, the Mining Location Laws of the State of Nevada; and all local laws, customs, and regulations, and on that day posted a Notice of Location at the place of discovery.

Said claim is located in the Maggie Creek Mining District, Eureka County, Nevada about 10250' in a Souly direction from McNamee Sta. This claim can further be described as being in Section(s) 26, Township(s) 37N, Range(s) 50E, M.D. B.&M.

The general course of said lode or vein is Northerly and Southerly and the locator claims 10 feet in a Northerly direction and 1490 feet in a Southerly direction from the point of discovery together with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim or a claim 1500 feet by 600 feet in size.

The location work consisted of the preparation of a map of said claim together with other claims in a common group as provided in NRS 517.040. Said map is being filed with and made a part of this Certificate, and was prepared from an actual field survey of this claim.

thence <u>Easterly</u> , <u>600</u> feet to a post marked	<u>N.E. Corner</u>	no. 1:	<u>G-14</u>

Each of the above-described corners and side-centers are 4" by 4" wooden posts at least 4½ feet in length, set one foot in the ground, and were erected on or before May 14th, 1981.
