

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that LABRADEX CORPORATION, by its agent, the undersigned, a citizen of the United States, on the 13th day of May, 1981 located the Mary No. 95 Lode Mining Claim in accordance with the 1872 Mining Laws of the United States and all subsequent acts, the Mining Location Laws of the State of Nevada, and all local laws, customs, and regulations, and on that day posted a Notice of Location at the place of discovery.

Said claim is located in the Magnie Creek Mining District, Eureka County, Nevada about 5,500' in a SE 1/4 direction from Microwave Sta.. This claim can further be described as being in Section(s) 33, Township(s) 33N, Range(s) 51E, M.D. B.&M.

The general course of said lode or vein is Northwly and Southwly and the locator claims 1370 feet in a Southwly direction and 30 feet in a Northwly direction from the point of discovery together with a width of 300 feet on each side of the center of the vein or lode along the entire length of said claim on a claim 1400 feet by 600 feet in size.

The location work consisted of the preparation of a map of said claim together with other claims in a common group as provided in NRS 517.040. Said map is being filed with and made a part of this Certificate, and was prepared from an actual field survey of this claim.
