## DEED

Excepting therefrom all uranium, thorium, or any other material which is determined to be peculiarly essential to the production of fissionable materials, whether or not of commercial value, as reserved in Patent from the United States of America, recorded December 19, 1947, in Book 23, Page 226, Deed Records, Eureka County, Nevada.

TOGETHER WITH ALL AND SINGULAR, the tenements, hereditaments and appurtenances thereunto belonging and in anywise appertaining. and the reversion and reversions, remainder and remainders, rents, issues and profits thereof.
