18 true and correct; that the gross value of the whole estate of  
19 said decedent does not exceed the sum of \$10,000.00; that the  
20 Petitioner, VICTOR ZAHNSTECHER, is the sole surviving child of  
21 the decedent; that so far as is known to the Petitioner, the decedent  
22 has no unpaid debts, and the expenses of last illness, funeral  
23 expenses, and expenses of administration have been paid, and there  
24 are no liens or encumbrances on decedent's property of record  
25 at the date of her death.

26 NOW, THEREFORE, IT IS ORDERED, ADJUDGED, AND DECREED  
27 that the whole of the property and estate of said NORMA ZAHNSTECHER,  
28 AKA NORMA ZAHN, deceased, be set aside to and the title thereof  
29 vested absolutely in VICTOR ZAHNSTECHER. The property of said
