RELEASE

By an Option Agreement, made and entered into the 12th day of May, 1980; THE 25 CORPORATION, a Kansas corporation, hereinafter called the "Optionor", granted unto NL INDUSTRIES, INC., a New Jersey corporation acting by and through its NL Baroid Division, hereinafter called "Baroid", the sole and exclusive right to enter upon and occupy certain tracts of land situated in Elko and Eureka Counties, Nevada for the purpose of conducting exploratory activities thereon in an effort to locate barite mineralization therein. By an Instrument, made and entered into the 17th day of October, 1980, the parties agreed to amend said Option Agreement only to the extent of adding and incorporating additional tracts of land therein which would be subject to the terms and conditions of the Option Agreement.

The Option Agreement also conferred upon Baroid the sole and exclusive right to purchase, upon terms and conditions specified therein, whatever interest the Optionor may have had or possessed in and to the barite mineral estate within the above mentioned tracts of land which, for purposes of this Release, are hereinafter collectively called the "Properties", more fully described in Exhibit "A" hereto and by this reference incorporated herein.

The term of said Option Agreement was for a period of one (1) year commencing from and after May 12, 1980 so that unless terminated prior thereto or the option therein exercised, said Option Agreement would lapse and expire by its own limitations at midnight on May 12, 1981. By these presents, Baroid hereby certifies and affirms that effective as of midnight on May 12, 1981, said Option Agreement lapsed and expired by its own limitations without the option therein being exercised and, therefore, is of no further force and effect. In addition, Baroid hereby releases and relinquishes unto the Optionor all of Baroid's rights and interests conferred by said Option Agreement which affect title and possessory rights to the Properties. Accordingly, the Optionor shall henceforth and accordingly retain all of its respective legal and equitable rights to the Properties, free and clear of all encumbrances, servitudes or other interests arising from said Option Agreement which have heretofore been created or granted in favor of or which have previously inured to the benefit of Baroid.
