

RELEASE AND DISCHARGE OF EXPLORATION AND
OPTION TO PURCHASE AGREEMENT

This Release and Discharge of Exploration and Option to Purchase Agreement made and entered into on the 16th day of June, 1981, by DOME EXPLORATION (US) Limited, a Delaware Corporation, hereinafter referred to as "Dome",

W I T N E S S E T H:

WHEREAS, on August 29, 1980, Charles A. Vaccaro and Leo G. Damele, of Eureka, Nevada, entered into that certain unrecorded Exploration and Option to Purchase Agreement and that certain Memorandum of Exploration and Option to Purchase Agreement with regard to certain real property, mining claims and mineral rights thereto situated in the County of Eureka, State of Nevada, more particularly described in Exhibit "A" attached hereto and incorporated by reference herein; and,

WHEREAS, pursuant to said Exploration and Option to Purchase Agreement Dome has given written notice of its intention to cancel said Exploration and Option to Purchase Agreement, and hereby cancels said Exploration and Option to Purchase Agreement.

NOW, THEREFORE, notice is hereby given as follows:

1. Dome Exploration (US) Limited does hereby fully release, acquit and forever discharge Charles A. Vaccaro and Leo G. Damele from any and all of their liabilities and obligations arising from the Exploration and Option to Purchase Agreement referred to above.

2. That Dome remises, releases and forever quitclaims unto said Charles A. Vaccaro and Leo G. Damele and their successors and assigns forever, all of its right, title and interest in and to certain real property, mining claims and mineral rights thereto, situated in the County of Eureka, State of Nevada, more particularly described in Exhibit "A" attached hereto and incorporated by reference herein,

TOGETHER WITH all dips, spurs, and angles, in and to all the ores, mineral-bearing quartz, rock and earth or other deposits therein or thereon, and in and to all of the rights, privileges and franchises thereto incident, and in and to all and singular the tenements, hereditaments and appurtenances thereunto belonging or in any wise appertaining, and the rents, issues and profits thereof; also in and to all the estate, right, title, interest, property, possession, claim and demand whatsoever, as well in law as in equity, of the said grantor, of, in or to the premises and every part and parcel thereof, with the appurtenances including all after acquired title.

TO HAVE AND TO HOLD all and singular the said real property, together with the appurtenances and privileges thereunto incident unto Charles A. Vaccaro and Leo G. Damele, their successors and assigns forever.
