

CERTIFICATE OF LOCATION OF LODE MINING CLAIMS

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies that he has located the T0 36 lode mining claim in Maggie Creek Mining District, Eureka County, in the State of Nevada on the 29th day of April, 1981, for Carlin Gold Mining Co., P.O. Box 979, Carlin, Nevada 89822. This claim is located in Township 33 North, Range 51 & 52 East, of the Mount Diablo Meridian in the following sections:

SW 1/4 of Sec 6 T33N R52E
NW 1/4 of Sec 7 T33N R52E
SE 1/4 of Sec 1 T33N R51E
NE 1/4 of Sec 12 T33N R51E

The claim is 1400 feet long and 600 feet wide and 20 feet is claimed in a North direction along the length of the claim and 1380 feet is claimed in a South direction along the length of the claim from the Location Monument at which a Notice of Location is posted, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit, as can be determined at this time is in a North and South direction.

The location of each corner of the claim is shown on the claim map that is filed herewith. The number, location, and markings on each boundary or corner monument is as follows:

No. 6: <u>WSC</u>	<u>WSC TO 36</u>	<u>PVC Pipe, 4" diam., 5' Long</u>

As erected on the ground each boundary or corner monument is marked as described above by an aluminum tag attached to the monument.

The monumentation and markings of the above mentioned corners on the ground was completed by the 30th day of April, 1981, and the location work consisted of making a claim map as provided in NRS. 517.040. Two copies of this map have been filed with the Eureka County Recorder and the \$15.00 lode claim filing fee has been paid to the County Recorder.
