1 for unpaid wages in the sum of ONE THOUSAND FIVE HUNDRED FOURTEEN
2 AND 10/100THS (\$1,514.10); statutory penalty wages in the amount
3 of TWO THOUSAND FIVE HUNDRED TWENTY THREE AND 50/100THS DOLLARS
4 (\$2,523.50); unpaid motel bill in the amount of ONE THOUSAND EIGHT
5 HUNDRED THREE AND 90/100THS DOLLARS (\$1,803.90); unreimbursed
6 automobile maintenance expenses in the amount of THREE HUNDRED
7 EIGHTY AND 62/100THS DOLLARS (\$380.62), which Defendant has failed
8 and refused to pay.

9 2. That Plaintiff is entitled to a reasonable attorney

21 maintenance expenses \$380.62, for a total of \$6,222.12.

22 2. For interest on the principal sum of \$6,222.12 at the
23 rate of twelve percent (12%) per annum from the date of June 23,
24 1981 until paid.

25 3. The sum of \$2,000.00 as and for reasonable attorney
26 fees, costs incurred to date in the sum of \$55.50, together with
27 all other legal costs to be incurred by Plaintiff in connection
28 herewith.
