CERTIFICATE OF LOCATION

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 10 feet from the location monument in a Northerly direction, and 1490 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "NW Corner of the FRAZIER CREEK # 22 Claim;" the southwest corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "SW Corner of the FRAZIER CREEK # 22 Claim;" the southeast corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "SE Corner of the FRAZIER CREEK # 22 Claim;" the northeast corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "NE Corner of the FRAZIER CREEK # 22 Claim." There is also a wood post 4"x4"x4 1/2' at the center of each side line.

The monumentation and marking of the corners was completed by the 7th day of July, 1981.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$18.00 lode claim filing fee has been paid to the County Recorder.
