CERTIFICATE OF LOCATION

THIS IS TO CERTIFY that the FRAZIER CREEK # 62 lode mining claim was located by:

To tie this claim to the Public Survey, begin at the SE/cor. of Sec. 35 within Township 24 North, Range 51 East, Mount Diablo Meridian, thence 6000' South and 4600' West to the northeast corner of this claim.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 1490 feet from the location monument in a Northerly direction, and 10 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "NW Corner of the FRAZIER CREEK # 62 Claim;" the southwest corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "SW Corner of the FRAZIER CREEK # 62 Claim;" the southeast corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "SE Corner of the FRAZIER CREEK # 62 Claim;" the northeast corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "NE Corner of the FRAZIER CREEK # 62 Claim." There is also a wood post 4"x4"x4 1/2' at the center of each side line.

The monumentation and marking of the corners was completed by the 7th day of July, 1981.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$18.00 lode claim filing fee has been paid to the County Recorder.
