CERTIFICATE OF LOCATION

To tie this claim to the Public Survey, begin at the SE/cor. of Sec. 35 within Township 24 North, Range 51 East, Mount Diablo Meridian, thence 10,500' South and 1400' East to the northeast corner of this claim.

We (or I) claim 1500 linear feet along the course of the mineral-bearing ledge, lode or vein, extending 10 feet from the location monument in a Northerly direction, and 1490 feet in a Southerly direction, together with 300 feet on each side of the center of the ledge for the entire length of the claim.

The northwest corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "NW Corner of the FRAZIER CREEK # 117 Claim;" the southwest corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "SW Corner of the FRAZIER CREEK # 117 Claim;" the southeast corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "SE Corner of the FRAZIER CREEK # 117 Claim;" the northeast corner is marked by a wood post 4"x4"x4 1/2' high, inscribed "NE Corner of the FRAZIER CREEK # 117 Claim." There is also a wood post 4"x4"x4 1/2' at the center of each side line.

The monumentation and marking of the corners was completed by the 7th day of July, 1981.

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$18.00 lode claim filing fee has been paid to the County Recorder.
