Commencing at the Southeast Corner which bears 300 feet Southerly and 750 feet Easterly from the location monument; thence Westerly 1500 feet to the SW Corner; thence Northerly 600 feet to the NW Corner; thence Easterly 1500 feet to the NE Corner; thence Southerly 600 feet to the SE Corner, the point of beginning. The discovery monument of this lode claim is situated approximately 6645 feet in a S. 14° 25' E. direction from the quarter corner of Sections 1 and 2, Township 22 North, Range 50 East, M.D.B. & M. This lode claim, Mill No. 1, is Northerly of Mill No. 1A and Southerly of Mill No. 2, lode claims.

Commencing at the Southeast Corner which bears 300 feet Southerly and 750 feet Easterly from the location monument; thence Westerly 1500 feet to the SW Corner; thence Northerly 600 feet to the NW Corner; thence Easterly 1500 feet to the NE Corner; thence Southerly 600 feet to the SE Corner, the point of beginning. The discovery monument of this lode claim is situated approximately 7240 feet in a S. 14° 55' E. direction from the quarter corner of Sections 1 and 2, Township 22 North, Range 50 East, M.D.B. & M.
