

CERTIFICATE OF LOCATION
LODE MINING CLAIM

KNOW ALL MEN BY THESE PRESENTS that the undersigned locators, having complied with all of the requirements of law and local rules and customs, have claimed and claim by right of discovery and location, a lode mining claim situated in Roberts Creek - Unknown Mining District, County of Eureka, State of Nevada, and hereby certify that:

(c) Said mining claim was located on June 15, 1981, in about Section 12, Township 22 North, Range 50 East, M.D.B. & M., and is bounded and described as follows:

Commencing at the Southeast Corner which bears 300 feet Southerly and 750 feet Easterly from the location monument; thence Westerly 1500 feet to the SW Corner; thence Northerly 600 feet to the NW Corner; thence Easterly 1500 feet to the NE Corner; thence Southerly 600 feet to the SE Corner, the point of beginning. The discovery monument of this lode claim is situated approximately 7240 feet in a S. 14° 55' E. direction from the quarter corner of Sections 1 and 2, Township 22 North, Range 50 East, M.D.B. & M. This lode claim, Mill No. 1A, is Northerly of Mill No. 1B and Southerly of Mill No. 1, lode claims.

(d) The undersigned claim 1500 feet, linear and horizontal in measurement, along the course of the vein, together with 300 feet in width on each side of the center of the vein, 750 feet of said lode running Westerly from the point of discovery (designated by the location monument). The general course of the lode as near as may be presently determined is Easterly and Westerly.

(e) Since the date of said location and prior to the date of this certificate, the undersigned caused work to be performed for location upon said mining claim consisting of maps as provided in NRS 517.040.

(f) The location monument, each corner and side line center marker is in each instance represented by a post at least 4 inches in diameter by 4½ feet in length and set 1 foot in the ground, the respective corner posts being marked as follows: SE Corner, Mill No. 1A; SW Corner, Mill No. 1A; NW Corner, Mill No. 1A; and NE Corner, Mill No. 1A.
