

# Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

The undersigned hereby certifies (certify) that he (she, they) has (have) located the Pat # 10 Lode Mining Claim in Section 24, Township 33 N, Range 50 E in the Mining District, in Eureka County, in the State of Nevada, on the 29 day of May, 1981.

The general course of the lode deposit and premises is from the East to the West.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by a Water Proof Marking Pen (Describe method of marking, such as "scribing the wood").
