The cost of the survey, the final stages of which are currently in progress, exceeds \$100.00 on and for each claim. The geochemical survey shows anomalous concentrations for all elements analyzed and in localized areas shows crude correlation between two or more. The sampling was executed by Dane Oberhansli, Field Technician, Box 613, Hawthorne, NV 89415, who has had three years of field experience in the mineral industry. The program was conceived, organized and directed by Lyle F. Campbell, Box 7377, Reno, NV 89510, a mining engineering graduate of the University of Minnesota, Minneapolis, MN who has 33 years of professional experience in engineering, mining and exploration.
