SUMMARY REPORT

September 22, 1981

This detailed report and accompanying geologic map is filed in compliance with the requirements of Title 30, United States Code, Section 28-1 for the STAG #1-#42 and STAG #48-#91 (STAG #35-#36 and STAG #48 as amended) group of 86 lode mining claims situated in the Mineral Hill Mining District of Eureka County in the State of Nevada. The claim location notices and maps showing their geographic locations are recorded in the Eureka County records in Book 85, pages 328-413 and/or as document numbers 75631-75724 and the amended locations in Book 87, pages 560-569 and/or as document numbers 76975-76979. They are recorded in the BLM records in Reno, Nevada under Serial No. NMC 163380 through NMC 163465. This report and the accompanying geologic map are the result of a portion of the assessment work for the assessment year ended September 1, 1981 on the aforementioned claims.

The work consisted of both reconnaissance and detailed geologic mapping of the entire claim group to further evaluate the discovery of valuable mineral deposits located thereon and to assist in planning further exploration and development work. The work was performed between Sept. 1, 1980 and August 3, 1981 by William D.
