I. That, as required and authorized by 30 U.S.C. § 28, Nev. Rev. Stat. 517.230 and 43 C.F.R. §§ 3833.2-1(a) and 3833.2-2, labor was performed, improvements were made, or expenditures for labor or improvements were made having a value of at least thirty eight thousand thirty five Dollars (\$38035.00) on the following unpatented mining claims situate in Sections 2,3,4,5, Township 23N, Range 49E; Sections 1,2,3,4,5,6, Township 23-1/2N, Range 49E; Sections 27,28,29,31,32,33,34,35, Township 24N, Range 49E and Section 36, Township 24N, Range 48-1/2E, Mount Diablo Meridian, in the Roberts Mining District, Eureka County, Nevada:

II. That the claim map showing said claims is filed as Document No. 73464 in the Eureka County, Nevada, records.

III. That such expenditures, work, or improvements were made, in the amount of at least One Hundred Dollars per claim, by or at the expense of Cargo Partners, owners of said claims, whose current mailing address is 3900 S. Wadsworth Boulevard, Suite 509, Lakewood, Colorado 80235, for the assessment year ending September 1, 1981.

IV. That such labor or improvements were performed or made by Hackworth Drilling, Vega Construction, Hazen Research, Skyline Labs, Inc., Monitor Geochemical Laboratory and Mineral Ventures, Inc., on behalf of the owners, between the dates of October 1, 1980 and August 20, 1981.

V.
