Such work or improvements and character consisted of the drilling 2 rotary drill holes to a total of 650 feet and the construction of drill roads and sites.

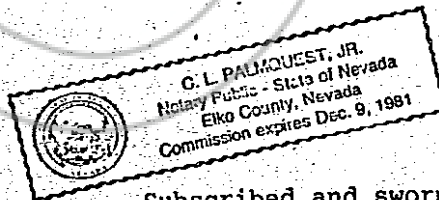
