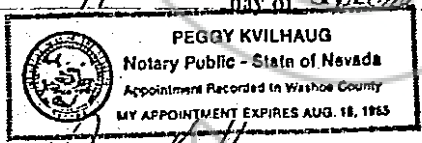

REPORT ON GEOCHEMICAL SURVEY

A geochemical survey was performed on Cordex's BLS claims, Section 16, T.34N., R.50E., during the period August 21 through August 28, 1981. The field work was done by Don Avery under the supervision of Andy Wallace, both geologists employed by Cordex. Sample analysis of the samples was performed by Rocky Mountain Geochemical Company, 840 Greg Street, Sparks, Nevada. The total expenditures for sampling and assaying exceeded \$3600.00.

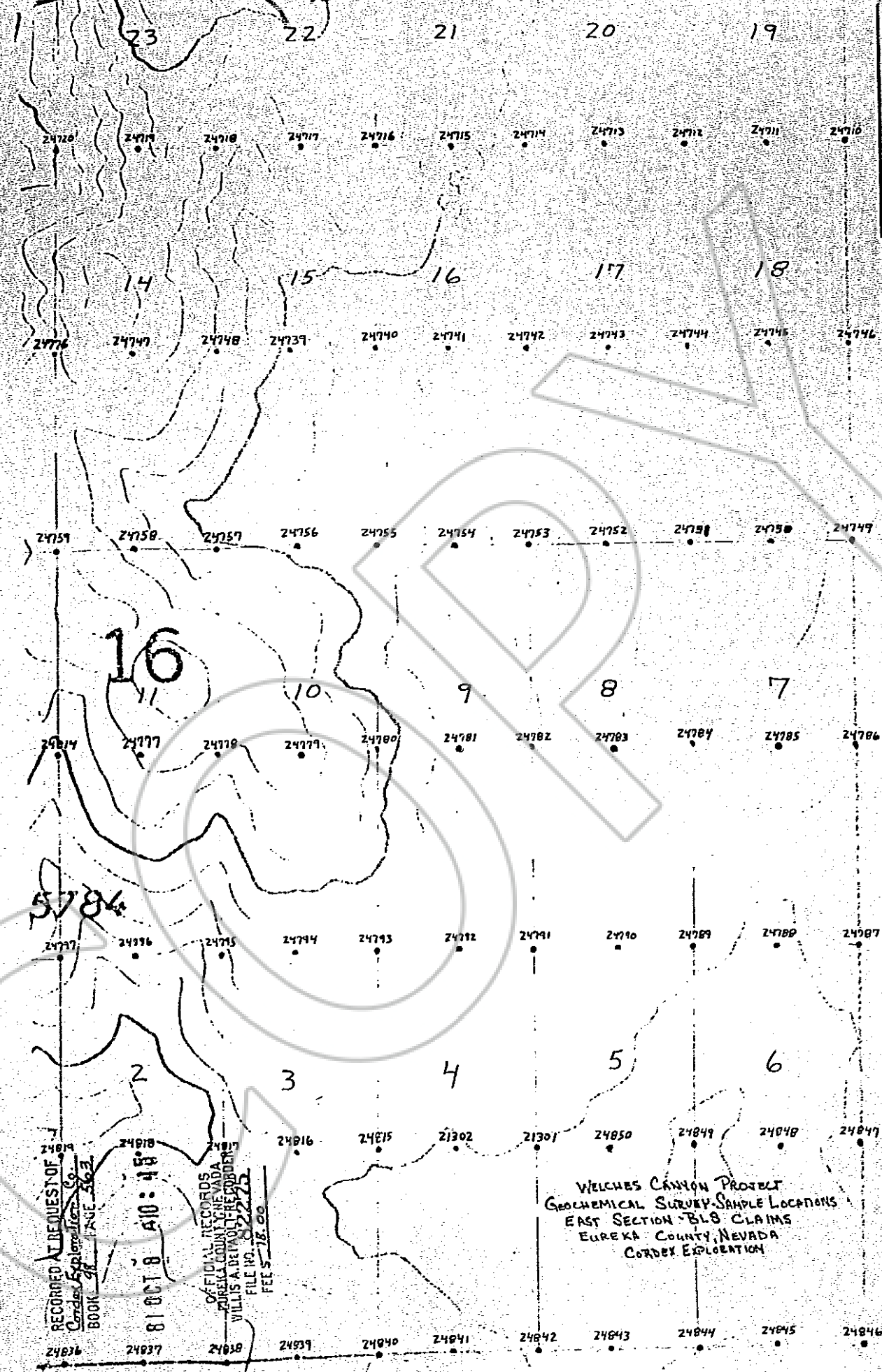
A total of 152 soil and rock chip samples were taken on 300 centers on a line spacing of 750'. Grid sampling covered each of the BLS claims, as shown on the attached map (1"=500'), which shows the BLS claims, sample numbers and locations, and topography.

The geochemical survey was designed to locate unknown geochemical anomalies worthy of drilling. It was unsuccessful however as all 152 samples were barren of gold and silver value.
