1. Three exploration drill roads were made on this claims block.

  - b. The second is approximately 1000 feet in length. It runs across HC 19 and HC 20 and a small portion of IM 11.
  - c. The third was an existing road, 2800 feet approximately on New York 1 and 2 and just touching HC 6.
