

DECREE OF DISSOLUTION

Now at this day comes the Petitioner in person and by her attorney, and the Respondent, although being now thrice solemnly called, comes not, but remains in default, whereupon this cause coming on regularly to be heard and being called, the Petitioner announces ready for trial; thereupon the Petitioner submits the cause to the Court upon her pleadings and proof, and the Court, after hearing the evidence, finds that the Petitioner has been a resident of this state for ninety days next preceding the commencement of this action, and that thirty days have elapsed since the filing of the petition therein; the Court further finds that there remains no reasonable likelihood that the marriage between the parties can be preserved, and that the marriage is, therefore, irretrievably broken.

It is therefore, ordered, adjudged and decreed by the Court that the marriage of Glenda Marie Tallent and Rainey Vencie Tallent is dissolved.

It is further ordered, adjudged and decreed by the Court that said Petitioner have the restoration of her former name of "Glenda Marie Page"; that maintenance is waived; Respondent is ordered to pay to Paul J. Harris the sum of \$350 as and for attorneys fees; Other orders: Respondent awarded 1977 Ford truck and all personal property in his possession. Petitioner is awarded all right, title and interest in the following four parcels of real estate: Lot 9 of Block of Eleanor Park #2, a subdivision of St. Louis County, Missouri, according to the plat thereof recorded in Plat Book 28, Page 55 of the Records of St. Louis County also known as 4411 Fairfield Avenue; and: NW1/4 of the NE1/4 of the NW1/4 of Section 17, Township 38 North, Range 70 East, M.D.B. & M., Elko County, Nevada; and: Block 32, Lot 7 Crescent Valley Ranch and Farms Unit #1 as shown of the official map filed in the office of the County Recorded of Eureka County, Nevada, on April 6, 1959; and: S1/2 of Lot 19, Section 7, Township 30 North, Range 4 East, M.D.B. & M., Lander County, Nevada. Petitioner further awarded 1976 Honda Civic and 1974 Coleman camper trailer as her own property plus all personal possessions and furnishings in the residence; the Petitioner represents to the Court that no marital property or separate property remains to be apportioned by the Court; and that said Respondent pay the costs herein incurred.
