

## MEMORANDUM FOR THE RECORD

## THE PURPOSE OF THIS MEMORANDUM IS

- A. To record that a Lease Agreement was duly executed the 5th day of June, 1980 between Mrs. Ray Holmes, Josephine Eather Goodrich, Norma Eather Croft, Margie Eather Heard, Gloria Eather Silva and Paul Laiolo (the Lessors) and Galli Mineral Associates (the Lessee).
- B. To record that this Lease Agreement pertains to the following patented lode mining claims, located within the Eureka Mining District, Eureka County, State of Nevada, to wit.

Clipper, Mineral Survey No. 154  
 Eureka, Mineral Survey No. 152  
 Keystone, Mineral Survey No. 153

- C. To record that the ownership interest of the above referenced Mining Claims, as best can be determined, is as follows:

- D. To record that this Lease Agreement gives unto Lessee the exclusive right for a period of Three (3) years, commencing on the effective date of this Lease Agreement, and Lessee to have the right to extend this Agreement for only one Three (3) year extension if the property is not placed into production, and the Lessee shall have the right to extend for successive Three (3) year periods under the same terms and conditions provided in the Lease Agreement after production has commenced within the periods set forth above.
- E. To record that such exclusive right commencing on date of execution, to prospect, drill and explore for, and to test, treat, extract, store, remove for testing, processing any and all minerals lying in, on or under the premises described herein.
- F. To record that the Lessors further grants to Lessee exclusive rights; to take and receive from Lessor a Lease Agreement covering the premises described herein upon all the terms, covenants and conditions contained in that certain Lease Agreement executed on the above stated date.

- G. To record that this Lease Agreement is subject to terms, conditions and provisions of the above mentioned unrecorded instrument executed between the parties dated the 5th day of June, 1980.
