

MEMORANDUM OF AGREEMENT  
FOR  
A MINING LEASE

The parties hereto have executed this Memorandum of a Mining Lease pursuant to the execution of certain conditions, which agreement was executed on the 28th day of September, 1979, by and between Willis A. and Arlene M. DePaoli, referred to as "Lessors", and Galli Mineral Associates, referred to as "Lessee". This mining lease is subject to the terms, conditions and provisions of the above mentioned unrecorded instrument executed between the parties dated September 28, 1979. Said mining lease relates to certain real property and mineral rights thereto, situated in the Eureka Mining District, Eureka County, State of Nevada, more particularly described in Exhibit "A", attached hereto and incorporated by reference herein.

Pursuant to said mining lease, Lessor grants and gives unto Galli Mineral Associates the exclusive right for a unspecified period (contingent on terms within the mining lease) to prospect, drill and explore for, and to test, treat, store and remove for testing, treating, any and all minerals lying in, on or under the premises described herein.

The Lessor further grants to Lessee the exclusive option at any time during the terms hereof (1. to purchase said premises; 2. assignment of said premises upon all the terms, covenants and conditions contained in that certain mining lease described; 3. to take and receive from the Lessor a mineral lease covering the premises described herein upon all of the terms, covenants and conditions contained in that certain mining lease described above).

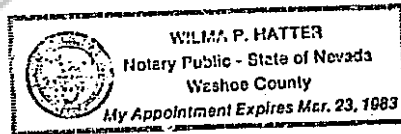

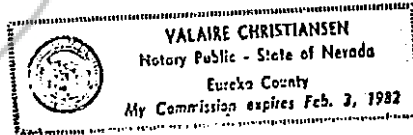
