TITLE: REPORT ON A GEOCHEMICAL SURVEY CONDUCTED ON THE FREEDOM 1  
THRU 8 LODE CLAIMS FOR THE 1980-81 ASSESSMENT PERIOD.

This report is in compliance with the Bureau of Land Management Circular No. 2289, "Regulations Pertaining to Mining Claims Under the General Mining Laws of 1872." (As contained in Title 43 of the Code of Federal Regulations.) Subpart § 3851.2, Inclusion of Surveys in Assessment Work.

The Freedom claims numbers 1 thru 8 are located in sections 25, 26 and 35 in T. 23 N., R 49 E M D B & M in Eureka County, Nevada.

Geochemical surveys were undertaken on the ground for mineral deposits. These surveys included the collection and preparation of geologic samples, (pre-dominantly soil samples.) (Soil samples were collected at a depth of 4 to 6 inches.) These samples were analyzed for precious metals and indicators. The preparation of these samples for analysis included drying, crushing, grinding and sifting to minus 80 mesh.

The cost of the work performed on these 8 claims amounted to more than \$800.00 dollars. The work covered the entire area on these 8 claims. Also, some of the area adjacent to these claims was included.

The basic findings of the geochemical survey have not been completed at this time. We are in the process of evaluating all of the data, chemical reports, geochemical maps, lab analyses, etc.
