

Certificate of Location of Lode Mining Claim

TO ALL WHOM IT MAY CONCERN:

IK #8 The undersigned hereby certifies (certify) that he (she, they) has (have) located the Lode Mining Claim in Section 32, Township 35 N, Range 51 E in the Eureka Mining District, in Eureka County, in the State of Nevada, on the 14 day of Nov, 1981.

The claim is 1500 feet long and 600 feet wide, and 150 feet is claimed in a North direction and 1350 feet in a South direction from the location monument, at which the Notice of Location is posted, lengthwise of the claim, together with 300 feet in width on each side of the center of the claim. The general course of the lode deposit and premises is from the North to the South.

The location and number of each corner of this claim is shown on the claim map that is filed herewith. On the ground, each corner of the claim is marked with its appropriate number by a Water proof Marking pen (Describe method of marking, such as "scribing the wood")

The description of each corner is as follows (describe the corner(s), such as "4x4 wooden post"):

- Corner No. 1 is a 4x4 post
- Corner No. 2 is a 4x4 post
- Corner No. 3 is a 4x4 post
- Corner No. 4 is a 4x4 post
- Corner No. 5 is a 4x4 post
- Corner No. 6 is a 4x4 post

The monumentation and marking of the corners was completed by the 20 day of Nov, 1981. (Must be within 20 days of posting notice of location)

The location work consisted of making a claim map as provided in NRS 517.040. Two copies of this claim map have been filed with the Eureka County Recorder, and the \$15.00 lode claim filing fee has been paid to the County Recorder.

NRS 517.300, Subsection 2.
