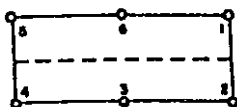
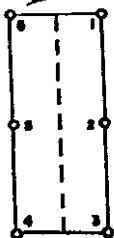

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the SPRING 21 Lode Mining Claim on this 1ST day of JANUARY, 1982, excepting that portion of the GAP N/A Lode Mining Claim located November N/A, 1981, by EXXON CORPORATION, situated in the MT.
