


CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the SPRING 124 Lode Mining Claim on this 16TH day of JANUARY, 1982, excepting that portion of the GAP 18 Lode Mining Claim located November 10, 1981, by EXXON CORPORATION, situated in the MT. HOPE Mining District, EUREKA County, Nevada.
