CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the SPRING 148 Lode Mining Claim on this 4TH day of JANUARY 19 82, excepting that portion of the GAP 21 Lode Mining Claim located November 15, 1981, by EXXON CORPORATION, situated in the MT.
