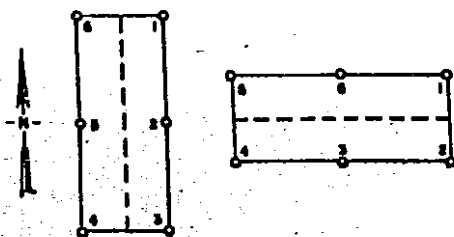

## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the SPRING 164 Lode Mining Claim on this 4TH day of JANUARY, 1982, excepting that portion of the GAP 29 Lode Mining Claim located November 11, 1981, by EXXON CORPORATION, situated in the MT. HOPE Mining District, EUREKA County, Nevada.

Said Claim is located in the NW (NE) (Quarter), Section(s) 12 (1) Township 22 NORTH (22 NORTH), Range 51 1/2 EAST (51 EAST), Mt. Diablo P. M., and more particularly described as follows, to-wit:

\* Beginning at the Northeast Corner Post Number 1,

Thence, 750.0 feet in a S 27°58'28" W direction to Post Number 2,  
Thence, 750.0 feet in a S 27°58'28" W direction to Post Number 3,  
Thence, 600.0 feet in a N 68°05'38" W direction to Post Number 4,  
Thence, 750.0 feet in a N 27°58'28" E direction to Post Number 5,  
Thence, 750.0 feet in a N 27°58'28" E direction to Post Number 6,  
Thence, 600.0 feet in a S 68°05'38" E direction to Post Number 1,

the point of beginning, and all posts being  $4'' \times 4'' \times 4''$ .

The Claim Monument on which the Notice is posted lies approximately midway between the two sides and is 1475 feet from the NORTHERLY end and 25 feet from the SOUTHERLY end.

To tie this Claim to the Public Survey, begin at the SOUTHWEST Corner, Section 36, Township 23 NORTH, Range 51 EAST, Mt. Diablo P. M., thence bear SOUTH, 735.7 feet and EAST, 6199.0 feet to the Northeast Corner of this Claim.\*
