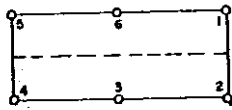
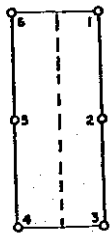
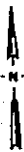

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the GAP 5 Lode Mining Claim on this 5TH day of NOVEMBER, 1981, situated in the MT. HOPE Mining District, EUREKA County, Nevada.
