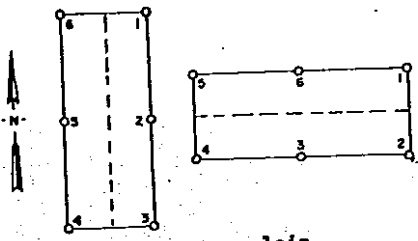

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the GAP 8 Lode Mining Claim on this 8TH day of NOVEMBER, 19 81, situated in the MT. HOPE Mining District, EUREKA County, Nevada.
