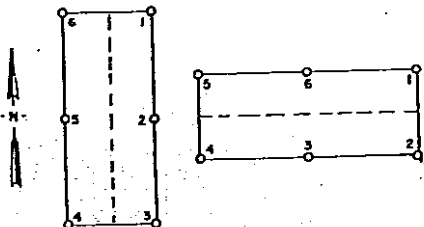

## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the under-  
signed, does hereby locate the GAP 19 Lode Mining Claim on this  
14TH day of NOVEMBER, 1981, situated in the MT. HOPE Mining  
District, EUREKA County, Nevada.

Said Claim is located in the NE&NW (Quarter) Section(s) 13,  
Township 22 NORTH, Range 51 1/2 EAST, Mt. Diablo P.M., and more particularly  
described as follows, to wit:

Thence, 190	feet in a S21°54'W	direction to Post No. 2,

Thence, 600	feet in a S76°22'E	direction to Post No. 6,
Thence, 600	feet in a S76°22'E	direction to Post No. 1,

the point of beginning and all posts being 4" x 4" x 4 1/2'.

The claim monument on which the Notice is posted lies approximately midway
