


CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the GAP 19 Lode Mining Claim on this 14TH day of NOVEMBER, 1981, situated in the MT. HOPE Mining District, EUREKA County, Nevada.

Said Claim is located in the NE&NW (Quarter) Section(s) 13, Township 22 NORTH, Range 51 1/2 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:
