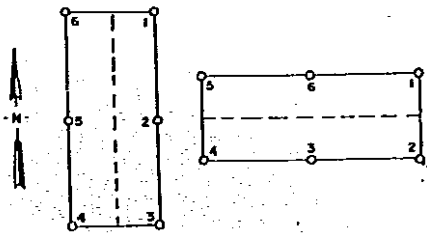

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the GAP 21 Lode Mining Claim on this 15TH day of NOVEMBER, 1981, situated in the MT. HOPE Mining District, EUREKA County, Nevada.

Said Claim is located in the SE6SW (Quarter) Section(s) 12 Township 22 NORTH, Range 51 1/2 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:
