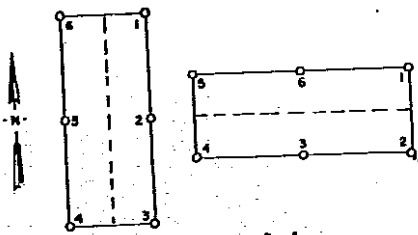

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the GAP 31 Lode Mining Claim on this 12TH day of NOVEMBER, 1981, situated in the MT. HOPE Mining District, EUREKA County, Nevada.

Said Claim is located in the NE (NW) ** (Quarter) Section(s) 1 (12) Township 22 N. (22 N.), Range 51 E. (51 1/2 E.) Mt. Diablo P.M., and more particularly described as follows, to wit: ** AND THE SE1/4, SECTION 36, T.23 N., R.51 E.

- Thence, 90 feet in a S69°36'E direction to Post No. 1,

the point of beginning and all posts being 4" x 4" x 4 1/2'.

The claim monument on which the Notice is posted lies approximately midway between the two sides and is 480 feet from the NORTHERLY end and 1020 feet from the SOUTHERLY end.

To tie this Claim to the Public Survey, begin at the SOUTHEAST corner, Section 36, Township 23 NORTH, Range 51 EAST, Mt. Diablo P.M., bear NORTH, 389.6 feet, and EAST, 252.7 feet to the northeast corner of this Claim. *
