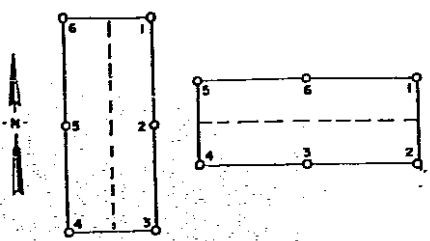

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the MI 486-R Lode Mining Claim on this 21ST day of NOVEMBER, 1981, situated in the MR. HOPE Mining District, EUREKA County, Nevada.

Said Claim is located in the NW/4E (Quarter) Section(s) 18, Township 22 NORTH, Range 52 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:
