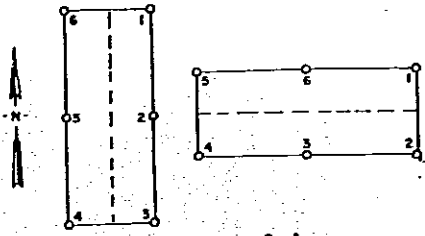

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the MH 473-R Lode Mining Claim on this 17TH day of NOVEMBER, 19 81, situated in the MT. HOPE Mining District, EUREKA County, Nevada.

Said Claim is located in the NW (Quarter) Section(s) 13 Township 22 NORTH, Range 51 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:

* Beginning at the northeast post No. 1,

- Thence, 220 feet in a SOUTH direction to Post No. 2,
- Thence, 400 feet in a WEST direction to Post No. 3,
