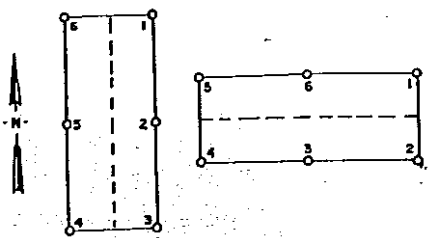

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the HOP 10 Lode Mining Claim on this 17TH day of NOVEMBER, 1981, situated in the MT. HOPE Mining District, EUREKA County, Nevada.

Said Claim is located in the NW (Quarter) Section(s) 13 Township 22 NORTH, Range 51 EAST, Mt. Diablo P.M., and more particularly described as follows, to wit:
