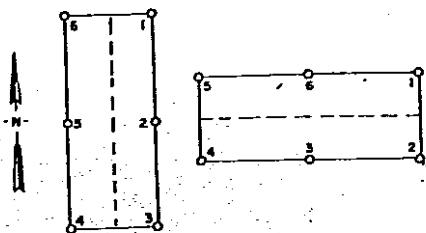

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the undersigned, does hereby locate the HOP 11 Lode Mining Claim on this 17TH day of NOVEMBER, 1981, situated in the MT. HOPE Mining District, EUREKA County, Nevada.
