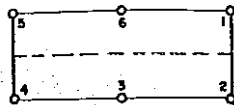
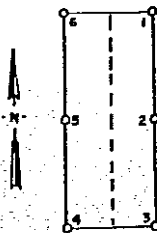

CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the under-
signed, does hereby locate the HOP 7 Lode Mining Claim on this

District, EUREKA County, Nevada.

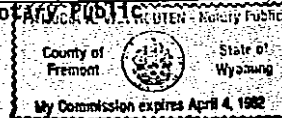
