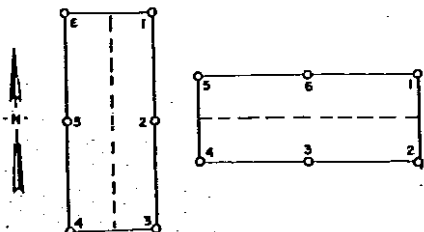

## CERTIFICATE OF LOCATION - NEVADA

THE UNDERSIGNED, hereby certifies that EXXON CORPORATION, by its Agent, the under-  
signed, does hereby locate the HOP 8 Lode Mining Claim on this  
19TH day of NOVEMBER, 1981, situated in the MT. HOPE Mining  
District, EUREKA County, Nevada.

Said Claim is located in the SE (SW) (Quarter) Section(s) 36 (1),  
Township 23 N. (22 N.), Range 51 E. (51 1/2 E), Mt. Diablo P.M., and more particularly

the point of beginning and all posts being 4" x 4" x 4 1/2".
