

QUITCLAIM DEED AND LEASEHOLD RELEASE

THIS INDENTURE is made and entered into this 5th day of August, 1981 by GRANTOR (referred in the singular):

W I T N E S S E T H:

That the GRANTOR, for and in consideration of TEN DOLLARS (\$10.00), in hand paid, and other good and valuable consideration, the receipt of which is hereby acknowledged, does by these presents remise, release and forever quitclaim to the GRANTEE such portion of the right, title and interest of the GRANTOR, as acquired by the GRANTOR by virtue of that certain Lease made between GRANTOR and GRANTEE as of February 14, 1980, in and to those mineral lands located in Eureka County, Nevada, more particularly described in Section 1, Exhibit A, attached hereto and made a part hereof.

TOGETHER WITH, all and singular, the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, and the rents, issues and profits thereof.

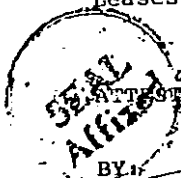

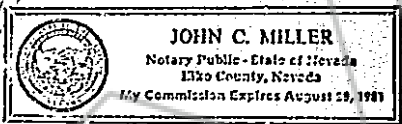

That certain Lease dated as of February 14, 1980 between Occidental Minerals Corporation, Lessor, to Carlin Gold Mining Company, a Memorandum of which Lease is recorded in Book _____ of Official Records, page _____, Records of Eureka County, Nevada, covering an undivided $47\frac{1}{2}\%$ of the mineral rights in, to and under those certain lots, pieces or parcels of land situated in Eureka County, Nevada, more particularly described as follows:

TOWNSHIP 34 NORTH, RANGE 51 EAST, MDB&M

Section 13: All; *1855 and except the North Half of the Northeast Quarter and the North Half of the South Half of the Northeast Quarter.*

3. That certain Lease dated February 14, 1980, between Lido A. Puccinelli, a single man and Leo J. Puccinelli and Gertrude F. Puccinelli, his wife, Lessors, to Carlin Gold Mining Company, a Memorandum of which Lease is recorded in Book 80 of Official Records, pages 66-69, Records of Eureka County, Nevada, covering an undivided 5% of the mineral rights in, to and under those certain lots, pieces, or parcels of land described in 1, above.
