

CONFIRMATION DEED

THIS CONFIRMATION DEED is made on the 16th day of December, 1981, by and between LOUISE M. MARVEL, a widow, of Battle Mountain, Nevada, hereinafter referred to as Grantor; and MARSHA M. GRANT, RICHARD J. MARVEL, THOMAS P. MARVEL, SUSAN M. BARNES, MICHAEL G. MARVEL, SALLY M. HOLMAN, JOSEPH C. MARVEL, PETER J. MARVEL, AMY L. MARVEL, SHARON M. ANDREASEN, JOHN E. MARVEL, and MICHELLE M. SLAGLE, hereinafter collectively referred to as Grantees;

W I T N E S S E T H:

WHEREAS, said Gift Deed incorporated herein mistakenly and erroneously set forth the respective percentage interests gifted to Grantees from Grantor's twenty-five percent (25%) interest, right and title in and to the minerals, mineral deposits, mineral rights, mineral interests, oil, gas, and geothermal resources, in, on, or under all those certain lots, pieces, or parcels of land situate, lying, and being in the Counties of Elko, Lander, Eureka, Humboldt, and Pershing, State of Nevada, and those certain unpatented mining claims located in the County of Elko, State of Nevada, which real property and claims were described in said Gift Deed;

WHEREAS, Grantor desires to herein set forth Grantor's true intent in making said conveyance, assignment and gift, to correct said errors and to accurately express, reflect and clarify in every respect the gift made therein.

NOW, THEREFORE, for love and affection Grantor does hereby grant, bargain, convey, assign, give and deliver to Grantees, as their sole and separate property, and to their heirs and assigns accordingly, the following undivided percentage interests, as confirmed and corrected herein:

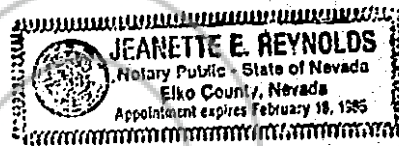
