

ASSUMPTION AGREEMENT

PETER M. TOMERA and TONI LYNN TOMERA, husband and wife, as joint tenants to an undivided one-half interest, and THOMAS J. TOMERA and PATSY SUE TOMERA, husband and wife, as joint tenants to an undivided one-half interest, of the County of Elko, State of Nevada, having purchased that certain real property described in a Deed of Trust dated April 15, 1973, executed by ROY SHURTZ and LISA SHURTZ, his wife, to FRONTIER TITLE COMPANY, Trustee, in favor of BATTISTA TOMERA, JR., a married man, as to an undivided one-half interest, and GEORGE TOMERA, a single man, as to an undivided one-half interest, which Deed of Trust was recorded March 14, 1979 in Book 69, Page 265, File No. 67925, Official Records, Eureka County, Nevada, which Deed of Trust was given to secure a Promissory Note in the principal sum of Six Hundred Thousand and No/100ths Dollars (\$600,000.00), upon which there is now owing the sum of \$345,891.46, with interest paid to April 15, 1981; and said PETER M.
