QUITCLAIM DEED

THIS QUITCLAIM DEED, made this 2nd day of March, 1982 between LEO J. PUCCINELLI and his wife, GERTRUDE F. PUCCINELLI, and LIDO A. PUCCINELLI, an unmarried man, of Elko, Nevada, as "GRANTORS;" and CARLIN GOLD MINING COMPANY, a Delaware corporation, P. O. Box 979, Carlin, Nevada, 89822, as "GRANTEE;"

W I T N E S S E T H:

That the GRANTORS, for and in consideration of the sum of TEN AND 00/100 DOLLARS (\$10.00), and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, do hereby remise, release and forever quitclaim unto the GRANTEE all of their right, title and interest in and to those certain lands situate in Eureka County, State of Nevada, more particularly described as follows:

Township 34 North, Range 52 East, M.D.B.&M.

Section 31: Lots 1 and 2 (W $\frac{1}{2}$ NW $\frac{1}{4}$); E $\frac{1}{2}$ NW $\frac{1}{4}$; N $\frac{1}{2}$ SE $\frac{1}{4}$;
Lots 3 and 4 (W $\frac{1}{2}$ SW $\frac{1}{4}$); E $\frac{1}{2}$ SW $\frac{1}{4}$; S $\frac{1}{2}$ SE $\frac{1}{4}$;
(as to a 5% mineral interest)

Township 34 North, Range 51 East, M.D.B.&M.

Section 36: E $\frac{1}{2}$ NE $\frac{1}{4}$ (as to a 5% mineral interest)

INCLUDING all of GRANTORS' rights in and to said mineral estate, and including, but not limited to, any rights to use the surface estate for mining purposes, GRANTORS representing to GRANTEE that GRANTORS are the owners of, and convey to GRANTEE an undivided ONE-TWENTIETH (1/20 or 5%) interest in the mineral estate.

RESERVING UNTO the GRANTORS, their heirs, successors and assigns, a FOUR-TENTHS OF ONE PERCENT (.4%)(i.e. 8% on 5% interest) non-participating royalty on gross sales revenues of all ores produced from the properties set forth above, such royalty applying to crude ores only and not concentrates. To the extent that the GRANTORS, their heirs, successors and assigns, own a lesser interest than FIVE PERCENT (5%) in the mineral estate, the GRANTEE will pay the GRANTORS, their heirs, successors and assigns only that percentage of the royalty due that is attributable to the GRANTORS' percentage ownership in the mineral estate.

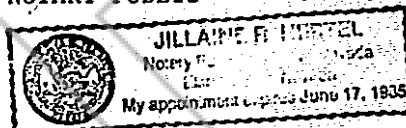

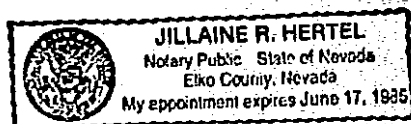
