All that real property, situate in the State of Nevada, County of Eureka and being more particularly described as follows: Southwest Quarter The South Half of the Northwest Quarter of Section 5, Township 30 North, Range 49 East M.D.B. & M. as per Government Survey.

SUBJECT to any portion of said lands within the lines of public road as now established.
SUBJECT to existing rights in use or of record in favor of the public or third parties for highways, roads, railroads, pipelines, telephones, telegraph and electrical transmission lines, canals, laterals and drains.
SUBJECT to the reservations contained in a deed between Crescent Valley Ranch & Farms and Glenn B. McKinney and Mary L. McKinney, husband and wife recorded July 20, 1961 in Book 26 of Deeds, page 88, file no. 35482, Eureka County Records as follows:
