


RELOCATION  
CERTIFICATE OF MINING LOCATION

The general course of this claim is North/South. This claim is 1500 feet in length along the course of the claim, being 1490 feet from the point of discovery in a North direction to the North end line of this claim, and 10 feet in a South direction to the South end line of the claim. This claim is 600 feet in width, being 300 feet in width on each side of the center line of the claim.


