 LOSE CLAIM ON PUBLIC DOMAIN

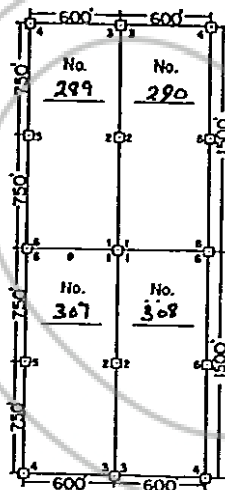

This claim is located all or in part in the following quarter section(s), township(s) and range(s):

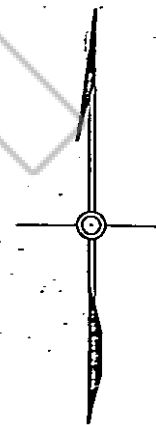
