NOTICE AND CERTIFICATE OF LOCATION - MILL SITE - NEVADA

NOTICE IS HEREBY GIVEN AND CERTIFIED that EXXON CORPORATION, by its undersigned Agent, hereby locates the Silver Butte #1 Mill Site on this 12 day of April, 1982, in accordance with the mining laws of the United States of America and of the State of Nevada.

thence approximately 466.69 feet in a Southerly direction to Post No. 2,  
thence approximately 466.69 feet in a Westerly direction to Post No. 3,  
thence approximately 466.69 feet in a Northerly direction to Post No. 4,  
thence approximately 466.69 feet in a Easterly direction to Post No. 1,

The point of beginning and all posts referred to above measure 4 inches by 4 inches by 4 1/2 feet.

The monument on which this notice of location is posted is at a point along the north boundary of the Mill Site approximately 0 feet from the easterly side and 466.69 feet from the westerly side of the Mill Site.

To tie this Mill Site to an official corner of the United States public land survey, begin at the Southwest corner of Section 21, Township 25 North, Range 51 East, Mt. Diablo P.M., bear North 42° 26' West, 7,875.70 feet, to the northeast corner of this Mill Site.
