CERTIFICATE OF LOCATION

LODE CLAIM

The undersigned, hereby certifies that he has located a mining claim in the Unnamed Mining District, County of Eureka, State of Nevada, on a vein or lode known as the Vinin. The name of this claim is Lyndall #110.

The Northeast corner is marked by a 4" ^{dia.} post 4 1/2 feet high inscribed NE corner of Lyndall #110, the Northwest corner is marked by a 4" ^{dia.} post 4 1/2 feet high inscribed NW corner of Lyndall #110, the Southeast corner is marked by a 4" ^{dia.} post 4 1/2 feet high inscribed SE corner of Lyndall #110, the Southwest corner is marked by a 4" ^{dia.} post 4 1/2 feet high inscribed SW corner of Lyndall #110. There is a 4" ^{dia.} post 4 1/2 feet high at the center of each side-line.

The discovery work has been done and the location work completed since April 24, 1982. The location work consisted of making a claim map as provided in NRS 517.040. Two copies of the map have been filed with the Eureka County Recorder, and the \$15.00 lode claim fee has been paid to the county recorder.
